Suspected case in school.	Staff, pupils, parents, visitors - contracting Coronavirus (COVID 19)	<ul style="list-style-type: none"> <li>• Medical room –disabled toilet (ideally hard floored, ventilated, ideally with a closed door or minimum 2m away from people).</li> <li>• If a child is awaiting collection, they will be moved, to the medical isolation room or if the weather is favourable they will wait outside for them to be collected from school.</li> <li>• Contact will be made with pupils’ parents in line with school policy.</li> <li>• In exceptional circumstances, if a pupil’s parents cannot arrange to have their child collected, if it is age-appropriate and safe to do so, the child is directed to walk, cycle or scoot home. - School will use available space to maximise distance between pupils and between staff & other adults on site.
- Steps are in place to limit interaction, sharing of rooms and social spaces between groups as much as possible.

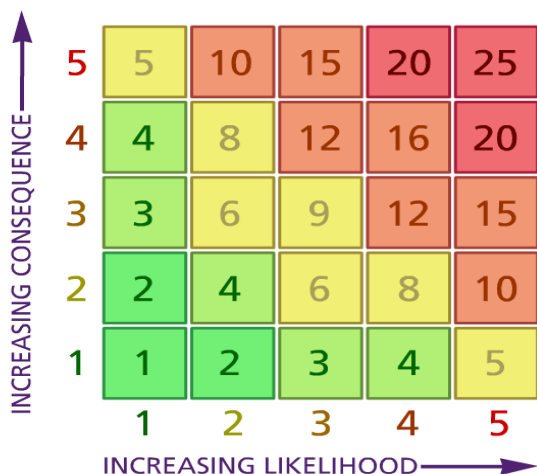
