

**Background information**

**School Opening**

DfE guidance for schools during the coronavirus COVID 19 pandemic has been that schools are required to have a full school opening risk assessment which is regularly reviewed and updated, treating them as 'living documents', as the circumstances in your school and the public health advice changes. This includes having active arrangements in place to monitor whether the controls are effective and working as planned.

This risk assessment applies to:

- primary schools
- secondary schools (including sixth forms)
- special schools, special post-16 providers and alternative provision
- 16 to 19 academies
- infant, junior, middle, upper schools

**Please note that this risk assessment has been created in line with the current guidance. It contains sample control measures that fit with the DfE system of controls. One size does not fit all, and schools should make this model risk assessment their own and reflect any local measures, particularly local HPT's guidance.**

		<ul style="list-style-type: none"> <li>When working with pupils who cough, spit, vomit or require intimate care but do not have coronavirus symptoms, staff only wear PPE that would routinely be worn.</li> <li>Staff are trained in correct use and disposal of PPE.</li> </ul>		
<p><b>School fails to ensure good hygiene &amp; cleaning standards in school to reduce risk of transmission.</b></p> <p><i>All settings unless indicated</i></p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<p><b>Hand hygiene -</b></p> <ul style="list-style-type: none"> <li>School will continue to ensure that staff &amp; pupils maintain high standards of hand hygiene.</li> <li>Suitable facilities are provided for individuals to wash/sanitise their hands regularly</li> <li>Pupils are supervised, where appropriate, to use hand sanitizer safely.</li> </ul> <p><b>Respiratory hygiene</b></p> <ul style="list-style-type: none"> <li>School emphasises the ‘catch it, bin it, kill it’ approach with bins &amp; tissues available.</li> </ul> <p><b>Cleaning</b></p> <ul style="list-style-type: none"> <li>School will maintain appropriate cleaning regimes, using standard products such as detergents with a focus on frequently touched areas.</li> <li>Appropriate cleaning schedules are in place and include regular cleaning of areas and equipment: Cleaner to attend school site during the school day for enhanced cleaning of toilets and regular touch points across the school. All school staff to clean the tables at lunchtime.</li> </ul>	<b>3X2=6</b>	
<p><b>Social distancing - failing to manage mixing and ‘bubbles.’</b></p> <p><i>All settings unless indicated</i></p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<ul style="list-style-type: none"> <li>Staff and pupils are informed they no longer need to adhere to social distancing measures in school unless directed.</li> <li>Pupils are informed they no longer need to be separated into bubbles in school.</li> <li>In the event of a school or local outbreak, the school adheres to the advice of a director of public health, which may include returning to social distancing measures, including pupil bubbles.</li> <li><i>School has planned carefully following the latest DfE/PHE guidance and will follow all measures at a steady pace.</i></li> </ul>	<b>3X2=6</b>	

		<ul style="list-style-type: none"> <li>• <i>Assemblies can be reintroduced again, but school will re-introduce this gradually. Mixture of smaller face to face assemblies with some remote assemblies still taking place.</i></li> <li>• <i>Staggered starts, lunch and breaks to limit numbers do not need to take place. Filter system still in place with children accessing the school site from 8:40am- 8:50am.</i></li> <li>• <i>Staff do not need to work with only one group/bubble</i></li> <li>• <i>Staffrooms- staffroom will be open to all staff but staff will be asked to be conscious of ensuring that there are not too many people in there at once.</i></li> <li>• <i>Meetings, including with parents, teams, Zoom etc. may continue.- where possible, meetings with parents will still take place outside.</i></li> <li>• <i>Teaching or holding meetings in well-ventilated areas wherever possible, such as outdoors or indoors with windows open. ]</i></li> <li>• School has <b>outbreak management plans</b> in place to reintroduce bubbles temporarily if it becomes necessary due to local outbreaks or increases in cases at the instruction of PHE Teams. <p><b>[UPDATED]</b> Ventilation - failure to ensure all occupied spaces are well ventilated.</p> <p>All settings unless indicated</p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<ul style="list-style-type: none"> <li>• When school is in operation, it is well ventilated with comfortable teaching environments.</li> <li>• When holding events where visitors are on site e.g. school plays, ventilation is increased.</li> <li>• School has competent ventilation engineers to help assess the systems in place and how to utilise them correctly.</li> <li>• Mechanical ventilation is adjusted to increase the ventilation rate wherever possible and checked to confirm that normal operation meets current guidance and that only fresh outside air is circulated.</li> <li>• Systems should be adjusted to full fresh air or, if this is not possible, then systems should be operated as normal as long as they are within a single room and supplemented by an outdoor air supply.</li> <li>• All mechanical ventilation systems are maintained in accordance with the manufacturers' recommendations.</li> </ul>	<p><b>3X2=6</b></p>	<p>School is awaiting delivery of carbon dioxide monitors. These will be distributed across school (on arrival) depending on how many received.</p>

		<ul style="list-style-type: none"> <li>• School opens external windows, doors &amp; internal doors (if they are not fire doors and where safe to do so) to increase ventilation.</li> <li>• During colder weather, the need for increased ventilation while maintaining a comfortable temperature is balanced; opening higher vents, arranging seating away from draughts.</li> <li>• In cooler weather to reduce thermal discomfort caused by increased ventilation, pupils can wear additional, suitable indoor items of clothing in addition to their usual uniform</li> <li>• Purging or airing rooms as frequently as possible to improve ventilation usually when the room is unoccupied.</li> <li>• Outside space will be used, where practical.</li> </ul> <p><b>Co2 monitors</b></p> <ul style="list-style-type: none"> <li>• CO2 monitors will also be provided to all state-funded education settings from September, so staff can quickly identify where ventilation needs to be improved. Further information will be issued as monitors are rolled out.</li> </ul> <p><i>Consider the use of Carbon dioxide (CO2) monitors to help identify where a space is poorly ventilated with schools encouraged to take steps to improve ventilation if CO2 readings are consistently high. Check manufacturers' instructions.</i></p> <p><i>See The Health and Safety Executive <a href="#">guidance on air conditioning and ventilation during the coronavirus outbreak</a> &amp; <a href="#">CIBSE COVID</a> advice provides more information.</i></p>		
<p><b>NHS Test &amp; Trace - School failing to manage tracing close contacts</b></p> <p><b>All settings unless indicated</b></p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<ul style="list-style-type: none"> <li>• School makes staff aware that it is not responsible for Test and Trace contacting. This will be taken over by the NHS Test and Trace service</li> <li>• NHS Test and Trace will work with the positive case and/or parent to identify close contacts.</li> <li>• Contacts from a school setting will only be traced by NHS Test and Trace where the positive case specifically identifies the individual as being a close contact.</li> </ul>	<p><b>3X2=6</b></p>	

		<ul style="list-style-type: none"> <li>• School may be contacted in exceptional cases to help with identifying close contacts (as currently happens in managing other infectious diseases).</li> <li>• School will continue to work with the local director of Public Health &amp; local HP Teams in the case of a local outbreak and if the area becomes an Enhanced Support Area.</li> <li>• Anyone in school who displays symptoms is encouraged to get a PCR test</li> <li>• Staff, pupils and parents are made aware that they are not required to self-isolate if they live in the same household as someone with COVID-19, or are a close contact of someone with COVID-19, and any of the following apply: <ul style="list-style-type: none"> <li>○ they are fully vaccinated</li> <li>○ they are below the age of 18 years and 6 months</li> <li>○ they have taken part in or are currently part of an approved COVID-19 vaccine trial</li> <li>○ they are not able to get vaccinated for medical reasons</li> <li>○ Staff who do not need to isolate, and children and young people aged under 18 years 6 months who usually attend school, and have been identified as a close contact, should continue to attend school as normal.</li> </ul> </li> <li>• Instead, they will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a <a href="#">PCR test</a>. School will encourage all individuals to take a PCR test if advised to do so.</li> </ul> <p><b>Whilst awaiting the result of a PCR test</b></p> <ul style="list-style-type: none"> <li>○ Staff who do not need to isolate, and children and young people aged under 18 years 6 months who usually attend school, and have been identified as a close contact, continue to attend school as normal.</li> </ul> <ul style="list-style-type: none"> <li>• They do not need to wear a face covering within the school, but it is expected and recommended that these are worn when travelling on public or dedicated transport.</li> </ul>		
<b>[NEW] Weekend cases - Pupils or members of staff or visitors record a positive</b>	<b>Pupils, staff, visitors increased risk of transmission</b>	<ul style="list-style-type: none"> <li>• NHS track &amp; trace advises that school make contact with families and request the close contacts identified should attend for PCR tests.</li> </ul>	<b>3X2=6</b>	

<p><b>PCR test during the weekend with no details of contacts to assist NHS Track &amp; Trace.</b></p> <p><b>All settings unless indicated</b></p>		<ul style="list-style-type: none"> <li>School sends email to whole school community to recommend they access PCR test if concerned or if staff or pupils display symptoms.</li> <li>School monitors numbers of cases in case of potential outbreak and invokes Contingency Plan advice if thresholds reached. (See above for thresholds).</li> </ul>		
<p><b>Asymptomatic testing</b></p> <p><b>All settings unless indicated</b></p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<p><b>NB. Testing guidance is under review.</b></p> <ul style="list-style-type: none"> <li>School makes clear that testing is voluntary.</li> <li>Staff in all education settings are encouraged to test twice weekly at home until the testing guidance is <b>reviewed in September.</b></li> <li>Testing kits are stored securely in school at the correct temperature.</li> <li>A test kit log is in use and data held is stored in line with the school's <b>Data Protection Policy.</b></li> </ul> <p><b>Confirmatory PCR tests</b></p> <ul style="list-style-type: none"> <li>Staff and pupils with a positive LFD test result should self-isolate in line with the <a href="#">stay at home guidance for households with possible or confirmed coronavirus (COVID-19) infection.</a></li> <li>They will also need to <a href="#">get a free PCR test to check if they have COVID-19</a> &amp; self-isolate until they get the result.</li> <li>If the PCR test is taken within 2 days of the positive lateral flow test, and is negative, it overrides the self-test LFD test and the individual can return to school if they do not have COVID-19 symptoms.</li> </ul>	<p><b>3X2=6</b></p>	
<p><b>Asymptomatic testing</b></p> <p><b>Primary schools</b></p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19.</b></p>	<ul style="list-style-type: none"> <li>Primary age pupils (Y 6 and below) will not be expected to test over the summer period.</li> <li>Primary age pupils will be offered the 2 tests at an ATS at the beginning of the autumn term when they start at their secondary school in Y7.</li> </ul>	<p><b>3X2=6</b></p>	

		<ul style="list-style-type: none"> <li>School may choose, however, to start testing Y 6 pupils earlier, including in summer schools, depending on local HP Team advice.</li> </ul>		
<p><b>Contact with potential or confirmed coronavirus cases in school</b></p> <p>All settings unless indicated</p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<ul style="list-style-type: none"> <li>If anyone in the school develops coronavirus symptoms while at school, this is managed in line with local and national guidance. They are: <ul style="list-style-type: none"> <li>sent home to isolate for 10 days (includes the day symptoms started).</li> <li>advised to follow the guidance for <a href="#">households with possible or confirmed coronavirus infection</a>.</li> <li>advised to arrange a PCR test as soon as possible.</li> </ul> </li> <li>If a pupil is awaiting collection, they will be left in a well-ventilated room on their own if possible and, if safe to do so.</li> <li>Appropriate PPE will used if close contact is necessary.</li> <li>Anyone with symptoms is advised not to use public transport and, wherever possible, be collected by a member of their family or household.</li> <li>Any rooms used are cleaned thoroughly after they have left.</li> <li>Anyone who comes into contact with a symptomatic individual washes their hands thoroughly for 20 seconds with soap and warm running water or hand sanitiser.</li> <li>Staff members or pupils who have been in close contact with someone with symptoms do not need to self-isolate unless they develop symptoms.</li> <li>School can take the decision if a parent or carer insists on a pupil attending, to refuse the pupil, if in its reasonable judgement the pupil poses a risk of infection to the school community.</li> </ul>	<b>3X2=6</b>	
<p><b>Pregnant staff inadequate measures in place</b></p> <p>All settings unless indicated</p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<ul style="list-style-type: none"> <li>An individual risk assessment is carried out for pregnant staff with appropriate risk mitigation in line with the latest recommendations from DHSC, PHE &amp; RCOG. See <b>RA 026 New &amp; Expectant member of staff.</b></li> <li>Pregnant staff of any gestation are not required to continue working on site if this is not supported by the separate risk assessment.</li> </ul>	<p><b>0 x 0 = 0</b></p> <p><b>Pregnant staff over 28 weeks will not work on the school site-</b></p>	

		<ul style="list-style-type: none"> <li>Staff who are 28 weeks pregnant and beyond, or are pregnant and have an underlying health condition that puts them at a greater risk of severe illness from coronavirus at any gestation, are supported to take a more precautionary approach.</li> <li>The school ensures pregnant staff are able to adhere to any active national guidance on social distancing and/or advice for pregnant women considered to be clinically extremely vulnerable.</li> <li>The above principles on protecting pregnant staff also apply to pregnant pupils.</li> <li>Pregnant staff are encouraged to get vaccinated if possible.</li> </ul>	<b>will work from home.</b>	
<p><b>CEV staff inadequate measures in place.</b></p> <p><b>All settings unless indicated</b></p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<ul style="list-style-type: none"> <li><b>Clinically extremely vulnerable (CEV)</b> staff are no longer advised to shield but are encouraged to take extra precautions to protect themselves, and to follow the practical steps set out in the CEV guidance to minimise their risk of exposure to the virus.</li> <li>CEV currently encouraged &amp; supported to attend work if they cannot work from home.</li> <li>An individual risk assessment is in place for all CEV staff.</li> <li>Staff who live with those who are CEV attend the workplace but should ensure they follow the system of controls in place.</li> </ul>	<b>3X2=6</b>	
<p><b>[UPDATED] CEV pupil's school has inadequate measures in place.</b></p> <p><b>All settings unless indicated</b></p>	<p><b>Staff, pupils, visitors, contractors increased risk of transmission of COVID 19</b></p>	<ul style="list-style-type: none"> <li>Children and young people under the age of 18 are no longer considered to be clinically extremely vulnerable and should continue to follow the <a href="#">same guidance as everyone else</a>.</li> <li>A very small number of children and young people have been advised to isolate or reduce their social contact for short periods of time by their specialist, due to their general risk of infection rather than because of the COVID-19 pandemic. If this is the case, they should continue to follow the advice of their specialist.</li> <li>Pupils and students who live with someone who is CEV continue to attend school as normal.</li> <li>School liaises with the parents of CEV pupils, if identified, an individual risk assessment is completed.</li> </ul>	<b>3X2=6</b>	

		<ul style="list-style-type: none"> <li>The school collaborates with the LA to ensure that alternative arrangements for CEV pupils are in place to prepare for the event that the school site is required to close.</li> </ul>
